CONFERENCE HIGHLIGHTS



EDUCATION SESSIONS

Educational opportunities provided by this conference reflect current medical knowledge and practice. Attendance helps to ensure the provision of appropriate, evidence-based patient care and follows procedures critical to efficient on-scene operations. There are over 100 sessions, divided over numerous tracks, presented by experts in the field. Select sessions to build additional skills or follow the track that is most important to you.

CONTINUING EDUCATION CREDITS

PCWE-09 Virtual Reality Training for Emergency Personnel in Mass Casualty Response

Recent mass casualty events demonstrate that targeted hemorrhage control, swift extrication with minimal intervention, and immediate transport are priorities for care. However, integrating these skills into a dynamic, unstable, and active disaster scene is challenging and difficult to simulate. Using Unity, we created an interactive, immersive VR simulation designed for trainees to navigate a scene and triage approximately 10-15 injured patients. Patients are modeled after a universal avatar and have a variety of life-threatening and non-life threatening injuries (lacerations, sprains, hysteria, confusion). To assess performance, an automatic scoring system was developed to provide faculty evaluators with a summary of each participant's actions.

Have you ever driven home from a shift in complete silence, wondering how this all started? How did you get here, in EMS? The Zombie Apocalypse: Coming to a

Neighborhood Near You

It's not a matter of if fentanyl-laced Xylazine will make its way into my community, but when. For most, it's already here. Adulterated street drugs are not a new phenomenon. As long as there has been an illegal drug trade, people have been using various adulterants to enhance or alter the effects of drugs. However, with Xylazine, the unintended consequences of its use have left many of its users looking like literal zombies. In this presentation, we will explore the history of Xylazine, from its use in veterinary medicine to its first reported human use in the early 2000s in Puerto Rico. We will examine the synergistic effects Xylazine has with opioids and the economics behind how we arrived at this point with fentanyl-laced Xylazine. Additionally, we will discuss the signs and symptoms of Xylazine use and the differential diagnosis that can mask its use. Lastly, we will examine the systemic effects of Xylazine, notably the development of open sores on the body.

The concept behind Freedom House Ambulance was the brainchild of Dr. Peter Safar, who was also known as the "Father of CPR." Dr. Safar's vision, along with Medical Director Dr. Nancy Caroline, led to a host of advanced medical procedures now routinely performed by paramedics, including what is believed to be the first endotracheal intubation performed in the field by EMS.

Despite its integral role in EMS history, Freedom House Ambulance has been mostly forgotten over time.

John Moon is a former Freedom House Paramedic and retired Assistant Chief of Pittsburgh Emergency Medical Service. John was raised in Pittsburgh's Hill District and joined Freedom House, the First Emergency Medical Service staffed by Paramedics in 1972. Ketamine is inexpensive, has an excellent safety profile and multiple routes of administration, making it an optimal medication for EMS. Additionally, Ketamine has a wide therapeutic range making it ideal for multiple EMS applications. Providers will learn six mainstream EMS protocols for Ketamine administration along with indications, contraindications, and dosing. What else can we do to reduce the risk of it Happening again? Harris County ESD 11 uses a modified Failure Mode and Effect Analysis (FMEA) to answer these questions. We use a stratified approach to identify risk potential based on historical events. This presentation will provide an overview of this process starting with a Root Cause Analysis (RCA) to identify the highest and most frequent failures in EMS and then applies a modified FMEA to reduce the risk. This session will provide an overview of our RCA and FMEA process. Participants can expect to have a working knowledge of both processes using power point slides and lecture. In the United States, it is estimated that annually 356,000 adults experience out-of-hospital cardiac arrest as well as 23,000 pediatric cardiac arrests. Although approximately 90% of those people will not survive the event, the likelihood of survival increases with prompt intervention. According to the American Heart Association (AHA), early intervention that includes CPR and restoration of normal heart rhythm with the use of an AED increases the chance of survival. Bystander CPR education is critical but is only one piece of the multilevel effort to increase survival rates from cardiac arrest. As noted, CPR training in schools is an essential component and directly related to the goal of increasing bystander CPR rates. Reasons for low CPR training rates include the cost and time needed to complete a formal CPR training course. It's also essential to build community awareness about sudden cardiac arrest and empower citizens to act when they encounter an SCA victim. NJ HEART is a program that involves a public awareness campaign that includes CPR education throughout schools and other designated community areas, as well as any organization that is seeking information about SCA, how to perform CPR and wants to ensure that they have a plan in place to be prepared to response to a victim needing a heart emergency response.

Nationally, the number of patients with sensory needs is on the rise. Studies show that 5% to 16.5% of the general population have symptoms consistent with sensory processing disorders.
